

Terms and Conditions – Ice Break Esky Promotion 2020

1) The promotion

The promotion is the Ice Break Esky promotion (**Promotion**).

2) The Promoter

3) Entry requirements

To enter the Promotion, a person must:

- a) purchase any two Ice Break 500 ml products from the Promoter's Participating Store;
- b) add their name and phone number to their receipt (**Entry Form**); and
- c) deposit the Entry Form in the box provided at the Participating Store (collectively, **Entry Requirements**).

4) Winner consents

If an entrant becomes a winner of the Promotion, the entrant agrees to:
