



Terms and Conditions – World Burger Day 2021

1. The promotion

2. The Promoter

The Promotion will operate instore only at the Promoter's stores located in Ballarat, Breakwater, Canadian, Epsom, Euroa, Healesville, Kyabram, Kilmore, Kyneton, Mansfield, Strathfieldsaye and White Hills (**Participating Stores**).

The Promotion is NOT available for any delivery orders (including Skip and UberEats).

5. How it works
